ISSFAL welcomes membership by corporate and institutional organisations that are interested in the health impact of the dietary lipids.

## The current benefits accruing to all Corporate Members are as follows:

1. A Committee of Corporations, consisting of one representative from each Corporate Member, which has the right to choose two of its members to sit as full members of the ISSFAL Board of Directors, each for four year terms.
2. Dependent on the tier of membership, a discount of up to 50% on published exhibit space rates at any ISSFAL organized workshop, conference, seminar or congress.
3. Up to three free individual memberships per year, to individuals within the corporation or organisation specified by the nominated representative at the time the financial support is provided, and reconfirmed thereafter at the same point each year.
4. One free registration to any ISSFAL organised workshop, conference, seminar or congress, including the prestigious biennial international congress. The nominated contact person to advise the name of the individual to be specified on the registration.
5. Notification of, and involvement in, any ISSFAL initiative that has a bearing on public pronouncements in respect of dietary lipids, and any meetings that ISSFAL is organising.
